**STATEMENT OF INTENT:**

Cordova Electric Cooperative wishes to award two \$5,000 scholarships to anyone graduating in 2025 or who has graduated within the last 5 years. Scholarships will be awarded to anyone furthering their education at any college, vocational/technical school, or trade program.

**ELIGIBILITY CRITERIA:**

1. Must be a graduating CHS high school senior, homeschool student, or have passed the GED in the 2024/25 school year, or within the last 5 years.
2. Graduate's parents/legal guardians, or self must be a current member of Cordova Electric Cooperative.
3. Must submit a copy of high school transcript or transcripts from the most recent year of school.
4. Must respond to the following prompts. Answers may be given in an essay or other format, such as presentation, video, etc.
  - a. Describe your plans for future education.
  - b. When it comes to electricity, the goal is to provide energy that is renewable, sustainable, and resilient. In what ways do you see CEC striving toward, meeting, or exceeding these goals?
  - c. In what ways can CEC improve?
  - d. What is the ideal source of energy for Cordova's future?
5. Finalists will participate in a presentation/interview with the Scholarship Committee where applicant will present their response to the prompt and respond to questions from the committee.
