Heat Pump Incentive Program

Cordova Electric Cooperative (CEC) offers up to \$5,000 to members to offset the cost of purchasing and installing a heat pump. CEC has a heat pump rate class as well as a residential tier at 1,000 kWh.

To be eligible for the program, you must comply with the following:

- Heat pump must have been installed in the previous ninety days.
- Must be a new system (not used previously).
- Must be installed per manufacturer's requirements, which will likely require work by licensed mechanical and electrical contractors.
- Proof of purchase and payment of the material and/or labor.
- The amount requested must have been paid by the applicant and can't have been reimbursed by another entity.
- Have a CEC representative inspect the installed system.

Other terms:

- The program is only available once per member or household.
- This program is available on a first-come, first-served basis and may end at any time for any reason.
- The monthly credit will only last as long as the program is funded and may end at any time for any reason.
- Any tax liability arising from such payment shall be the sole responsibility of the member.
- CEC will file an IRS 1099 form for any amounts exceeding the IRS reporting limit.
- CEC will collect usage data to try to determine heat pump electric usage, but all data will be kept anonymous.
- CEC reserves the right to modify this program at any time at its sole discretion, without notice.
